.... *President's Message*

The fall seems to have flown by and all the concerns we had about the teacher evaluations and APPR, the elections, and the changes in our prescription coverage are now in the (immediate) past.

The Teachers Association has negotiated a satisfactory evaluation plan and we did not lose a large number of teachers as we had feared. Difficulty with the budget for 2013 remains a significant problem to be dealt with next year due to the tax cap restraints.

The elections went down to the wire for many candidates, including the President. NYSUT's endorsements of those who were pro-education helped President Obama and Representative Tim Bishop, as well as others, to win.

Currently the changes to our prescription plan are being thoroughly explained via the large mailing we all received recently from United Healthcare. I urge you to scan these booklets. Any question or concern that you have is probably covered there. The Abridged Formulary lists drugs alphabetically as well as by health condition. It also indicates what tier each drug is in (generic, preferred, and non-preferred) which determines the amount of co-pay. Also very helpful is the Pharmacy Directory which lists the pharmacies in the Empire Plan Medicare Rx network.

If you are an Empire Plan member, you should also have received your new prescription cards in the mail. If you have not, you should call them at 1-877-769-7447, twenty-four hours any day. These cards, a separate one for each member covered by your policy, are to be used starting January 1, 2013.

A new feature of this plan is that we will receive a monthly "Explanation of Benefits" statement for each month in which we purchase prescriptions. This will help to keep track of your purchases and give info and phone numbers to call for help.

As the year ends, I wish you all a wonderful holiday time and good health in 2013.

Input / Output

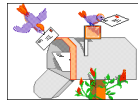

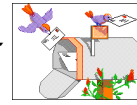
We hope you will consider donating to the NYSUT Disaster Relief Fund (see p. 4).

Welfare Trust Fund Benefits

From the many phone calls I've received in the past month, there seems to be a lot of confusion with the 2013 changes in the Empire Plan/United Health Care Prescription Drug Plan program. For most of us it will just mean an extra prescription drug plan card that we will have to present to a participating pharmacy when getting our prescriptions. Below is an explanation of the major changes to our Empire Plan that will take effect on January 1, 2013.

Effective January 1, the NYSHIP Empire Plan is making changes in prescription coverage. Those who are Medicare Primary and their dependents will be enrolled in **EMPIRE PLAN MEDICARE Rx**, a Medicare Part D prescription program. This change applies only to the Empire prescription drug coverage; it is not a part of the federal Prescription Part D. Changes are being made as part of the Affordable Care Act, designed to reduce drug costs for brand name and generic drugs.

- 50% discount for brand name drugs;
- 14% for generic drugs
- There will be a separate prescription ID card
- Co-pays will remain the same as or better than in-service enrollees
- Formularies will remain the same or better than in-service enrollees
- There will be no donut hole
- Each Empire enrollee may have only one Empire Medicare Rx Part D benefit. If both spouses have family coverage, they will have to choose which plan to stay with. If no choice is made, Empire will cancel the plan that has been in existence the longest. Where there is dual coverage for family and also an individual coverage for one of the partners, the individual cannot continue to receive coverage if the family plan continues.

• High income Medicare retirees (\$89,500 individual, \$170,000 family), will be subject to a premium surcharge. If the district pays for a retiree health plan (i.e. 25%/35%) that will continue with prescriptions. However, unlike Part B premiums, the district is not required to reimburse the surcharge.

In November of 2011, I went on an 18 day nature trip to the South Island of New Zealand (NZ is made up of two islands and smaller ones nearby) and Stewart Island (which is south of the southern tip of the Island). There were five of us from different states and two naturalists/guides - talk about personal attention.

The trip was fascinating! It is such a lovely country and the people are so open and natural. It is also very environmentally conscious. Sheep and cattle are grass/hay fed and stay out of doors all year long; no barns and little if any use of hormones. The chickens are free range and there is no use of hormones. The salmon is farm raised just off the coast, but there is no problem with pesticide run off as in the states; most farmers try to avoid using it.

They even have deer ranches - a way to solve the problem of introduced species & explosion of population. The only native mammals are three kinds of bats and marine mammals. They have many native birds and reptiles and plants. No matter where I went it was always very clean; not a scrap of paper or cigarette butt etc. to be seen. They have a big recycling program even in hotel rooms. At least 25% of the land area of the and Islands is made up of national parks, wildlife refuges etc.

As you may remember, Christchurch was hit with a huge earthquake back in February of 2011. The center of town was fenced off. It looked like the end of the world - empty buildings standing and barren streets. The old buildings made of stone or brick (from the 1800's) really fell apart. The newer buildings and high rises were still standing, but many panes of glass had fallen out and some were covered with wood panels. A local told me that 300 buildings in Christchurch have to be demolished before they can rebuild and 5,000 buildings/homes in the suburbs have to be demolished before they can be rebuilt.

The section and lovely hotel I stayed in for two nights across from Hagley Park had no damage. As I walked around the fenced area I could see lower buildings and homes that had postings of no damage on the outside, but damage inside or possible damage inside to be checked. Many people have left the city for jobs and housing in other towns. So sad. It will take .5.

many years for the city to come back to its thriving life. One street outside the fenced area set up box cars so that some businesses and shops could try to maintain a semblance of business, especially for the tourist trade since many well known sights were in the fenced in area. There was a place to sign up for a bus ride into the center of town (with a few hours wait list), and you had to sign a waiver of being responsible for yourself if any buildings should fall etc. I didn't want to waste time standing around waiting. I figured I'd see what I could see outside the fenced area (part of the sight seeing walk) and one could look through the holes made in the fencing at various points to see different parts toward of the center of town.

North of Christchurch is the town of Kaikoura which has a huge underwater canyon about a mile wide and just under a mile deep off the coast. It comes very close to the shore by one of the bays and sperm whales are found in this canyon all year long. The afternoon I was out on the water, the pod which had been in my area that morning decided to move further north. I saw lots of seabirds, of course, and I did see the wandering albatross that have ten foot wing spans as I did in Antarctica.

The Maori (pronounced Mar-ee) people arrived in NZ only 800 years ago. They seem to be pretty well integrated into the white society (unlike the Aborigines of Australia). We spent a half day with one of the descendants, who can trace his lineage back to a particular boat, seeing areas having to do with their history, culture etc. and then were hosted by his wife (of Scottish descent) and learning/partaking in traditional Maori hosting rituals. It was a very interesting afternoon.

Spent many days in temperate rain forests (at eco-resorts) which are very lush and have many birds as do the tropical rain forests, but the birds are not as colorful as they are in the tropics. Spent time at Fox Glacier which doesn't get as many tourists as the popular Franz Josef Glacier, but I'm getting a bit jaded after having seen many glaciers. The Kiwis are having the same quick glacial receding problem as we are having in Glacier National Park

When we were visiting a sheep ranch (stations have much larger acreage), there was a tent set up for the crew that would be filming scenes for the movie THE HOBBIT. Thirty trucks were to be coming the next day. The young policeman on guard was concerned that we seven were undercover photographers staking out a place on our drive up the mountain (the rancher's property). The owner showed where he was taking us and how long we would be.

The tent looked like a wedding tent from the road so neighbors had no idea about the forthcoming filming. But when Elijah Wood and Peter Jackson show up in Queenstown, someone may get suspicious especially when thirty trucks show up.

Milford Sound is a very magnificent place, with views of the mountains rising up from the water with many waterfalls cascading down. However, it was rainy and foggy in many places, which hampered the the dramatic views we experienced. On a trip, you have to take whatever Mother Nature gives you.

In the town of TeAnau we took a boat ride to see glowworms in TeAnau Cave. The cave was only discovered back in 1948. First there is the fascinating walk underground where one passes under glowworms on the roof of the cave and then the towboat (the guide does a hand over hand on a rope along the side of the cave) to a grotto where gazing up one thinks of the starry southern hemisphere nights. Just dazzling!

Mother Nature gave us a little twist on our Stewart Island stay. Six of us and the pilot flew over though it was "a bit windy". We landed on the tarmac (didn't know it until I looked out - what a pilot!) and no building, just the little runway - they used to land on a beach in a curved bay. And then for two days it rained on/off with gale winds (two systems colliding - one from Southeast Asia and one from Antarctica). People couldn't leave or arrive as planes were not flying. So we couldn't do two night hikes to see the blue penguin and kiwi colonies as we needed a boat as transport to another island and to the other side of the Stewart Island. We were lucky to manage a little van trip and a short day hike. Three quarters of Stewart Island is a national park.

The little town of Oban has a population of 400 which grows during the summer and has a very good recycling program so that it cuts down on the garbage to be shipped to 'the mainland' (the South Island).

When I was in Dunedin, there was an Occupy settlement in the town center park. Only seven tents, a small grandstand, but no people. A large sign hung telling what the 1%ers made in 2007 and what they are making now versus the 99%ers. That was it. Not much of a demonstration.

On our last evening we were supposed to go out on a boat, just for us, for dinner and to see various seabirds, but the captain didn't want to take a chance with the strong winds and tide (we might not be able to get back in). So Mother Nature did it again - she really wants me to come back. Needless-to-say, since Mother Nature threw us a few wrenches, the nature tour company has offered monetary credit toward a future trip which I thought was very nice.

So that's it in a nutshell. There were many other experiences, but this is long enough without them.

NOTE: Where the enrollee holds the family plan and is Medicare-primary but the dependents are not Medicare eligible, the dependents remain on the original prescription plan and also receive individual prescription cards.

If the holder of the family plan is not on Medicare but the spouse is, the spouse goes on Medicare Rx prescription coverage while the primary remains on the original plan. They each receive individual prescription cards.
